



Dédé Harris, Pet Nanny
Boarding Service Agreement

THIS AGREEMENT made this _____ day of _____ (month), _____ (year), by and between **The Pet Nanny** and _____ (Pet Owner).

WITNESSETH: That in consideration of the mutual covenants and agreements to be kept and performed on the part of said parties hereto, respectively as herein stated, the said **The Pet Nanny** does hereby covenant and agree that it shall:

I. IN CONSIDERATION of the sum of \$_____ (_____ dollars) per day for _____ days, paid by **Pet Owner**, provide loving care for the following pet(s): _____ during the owners' absence from _____ through _____ (Month/Day/Year). For the safety and well being of all pets, **The Pet Nanny** will continue its services at the regular rate until owner arrives to pick up their pet(s) or until notification of **Pet Owner's** return by telephone.

II. And said **Pet Owner** covenants and agrees that it shall:

Pay \$ _____ (_____ dollars) to reserve the services of **The Pet Nanny** for the aforementioned dates 50% which is non-refundable in the case of owner cancellation for services up to 24 (twenty-four) hours prior to start of service. All monies will be refunded if **The Pet Nanny** cancels. In the future a 50% down payment is required to reserve the services of **The Pet Nanny** with the same cancellation policy.

Balance of all monies owed to **The Pet Nanny** is due at the time the pet leaves custody of **The Pet Nanny**.

Given the understanding that all reasonable care and diligence will be taken in the care of pets and property, **Pet Owner** agrees to waive and release **The Pet Nanny** and its representatives for loss or damages of pet(s) and/or property. **Pet Owner** has given **The Pet Nanny** permission to care for their pet(s) and understands that they (**Pet Owner**) are solely and financially responsible for any damage or harm caused to or by their pet(s) while under the care of **The Pet Nanny**.

III. Other terms to be observed by and between **The Pet Nanny**, and **Pet Owner**:

In the event of an emergency, injury, or illness involving the health of any pet being cared for by **The Pet Nanny**, **Pet Owner** hereby authorizes **The Pet Nanny** to obtain veterinarian care, administer medication, and give other advisable attention as **The Pet Nanny** may deem necessary and such expenses shall be paid promptly by the **Pet Owner** who further authorizes **The Pet Nanny**, and/or its representatives, to incur veterinary costs in the name of the **Pet Owner**. **Pet Owner** agrees to indemnify and hold harmless **The Pet Nanny**, and/or its representatives, from any liability arising from such veterinary charges.

CONTINUING OBLIGATION:

It is agreed between **Pet Owner** and **The Pet Nanny** that this agreement contemplates **Pet Owner** will be in need of **The Pet Nanny** services from time to time in the future, and it is further understood that obligations contained herein shall apply to each provision of services in the future, without need of entering into another agreement, unless altered in writing and signed by the **Pet Owner** and **The Pet Nanny**.

This agreement shall be binding upon **The Pet Nanny** and **Pet Owner**, their successors, assigns and personal representatives. Time is of the essence on all undertakings. This agreement shall be enforced under the laws of the state of Washington. This is the entire agreement.
